Superintendent Mousalimas and the Board recognized students and coaches of the Venture Academy Hackathon team who recently competed in an H20 Hackathon event sponsored by IBM and the San Joaquin County Office of Education (SJCOE) STEM program. The team placed second in the overall competition and first place in terms of the application they developed to address a 20 percent reduction of water usage at their school site over a specific period of time.

Superintendent Mousalimas and the Board commended the Venture Academy Mock Trial team and their coaches for their fifth consecutive title at the San Joaquin County Mock Trial competition and their fifth-place finish at the California Mock Trial competition in Riverside. It was reported that the team has been invited to the world championship in New York next year.

1. 2018 - 2019 Budget Assumptions: Deputy Superintendent Scott Anderson reviewed the detailed 2018 - 2019 budget development instructions that were distributed to all departments at SJCOE highlighting the key assumptions related to employee costs. With regard to revenue, he explained that SJCOE would emerge from its hold harmless status in terms of the Local Control Funding Formula (LCFF) and also receive the proposed one-time unrestricted funding of approximately \$344 per ADA. Mr. Anderson concluded by saying that SJCOE will continue to be cautious and conservative and will continue to urge school districts in the county to do the same.
