Credential Application Annual Report: Human Resources Director Karen DePrater, reviewed the annual Credential Application Report that illustrates the number of credential applications processed by the San Joaquin County Office of Education during 2016 – 2017, including temporary teaching certificate applications. Ms. DePrater reported there was a total of 389 credential applications processed, 29 of which were renewal applications. In terms of temporary county certificates, a total of 950 applications were processed.

2. Declaration of Need: Karen DePrater presented the Declaration of Need for Fully Qualified Educators report and said that based on the actual needs and projected enrollment for the upcoming year, the area of anticipated need for emergency permits includes CLAD and English Learner Authorization.

The estimated number of limited assignment permits includes two multiple subject credentials, eight single subject credentials, and ten in the area of special education. The establishment of an intern program and participation in a Commission-approved university internship program serves as evidence of efforts to certify, assign, and develop fully-qualified teaching staff. This declaration will remain in force until June 30, 2018.
