IV. ITEMS SCHEDULED FOR INFORMATION:

- 12. Peer Assistance and Review Annual Report: Brandie Brunni, Division Director in Special Education, provided an update regarding the work of the PAR Committee. Ms. Brunni said that two teachers were referred this past year, one voluntarily and one self-referred. There were two consulting teachers who provided support to these two teachers. The self-referred teacher was excused from the program due to a satisfactory evaluation at the end of the school year. The voluntarily referred teacher decided to retire at the end of the school year. Although teaching staff is encouraged to take advantage of this support opportunity, Ms. Brunnie noted there were no teachers slated for participation during the 2014 2015 school year. She said the PAR Committee members plan to review the bylaws for the program during the next year.
- 13. Credential Application Annual Report: Dr. Founts reviewed this annual report showing the number of credential applications processed by the San Joaquin County Office of Education during 2013 2014, including temporary teaching certificate applications. A total of 365 new applications and 33 renewals were processed. In terms of temporary county certificates, there were a total of 630 applications processed.
- 14. Declaration of Need: Dr. Founts certified a Declaration of Need for Fully Qualified Educators to serve the San Joaquin County Alternative Education and Special Education programs during the 2014 2015 school year. Based on the year's actual needs and projected enrollment, the area of anticipated need for emergency permits include CLAD and English Learner Authorization. The estimated number of limited assignment permits includes two multiple subject credentials, eight single subject credentials, and ten in the area of special education. The establishment of an intern program and participation in a Commission-approved university internship program serves as evidence of efforts to certify, assign, and develop fully qualified teaching staff. This declaration will remain in force until June 30, 2015.
- 15. 2014 2015 San Joaquin County Board of Education Meeting Calendar: President Sorgent led the review and discussion regarding the proposed regular Board meeting calendar for the next school year indicating that the absence of a long-time Board member during the last discussion, the suggested compromises in meeting start times, and the seating of two new Board members required further discussion. He stated that the argument is that an evening start time will avail itself to increased public attendance. The discussion continued and a new suggestion included a rotation in the location of the meetings. It was agreed that consideration of a different start time and/or day for the Teachers College of San Joaquin meetings might be helpful. There was not unanimous agreement on any of the suggestions.
