- IV. RECOGNITION: Durham Ferry teacher, Shonna Beam, introduced the students from Venture Academy Family of School's Durham Ferry Equestrian Drill Team and explained what they do as team members in terms of animal care and team development. Board members Dyk and Gebhardt distributed certificates in recognition of their win at the recent California Coto Cup competition.

1. San Joaquin County Regional Occupational Center and Programs (ROC/P) Annual Report: Superintendent Mousalimas introduced Chris Kleinert and Julie Jansen, administrators in Career and Technical Education.

He reminded the Board that ROC/P has become Career and Technical Education and, as such, there will be two more years of the Annual ROC/P reports coming forward to the Board for information purposes.

Mr. Kleinert described the process the department had followed in an attempt to contact the 742 program completers from the 2013 – 2014 school year. Approximately 241 students were contacted and the program found that many were gainfully employed. Mr. Kleinert described the movement from a certificate program to an industry-recognized certificate program in the areas of cosmetology, health, and welding.

Ms. Jansen reported on the increased population at the cosmetology program indicating that many new students have enrolled as a result of the social media outreach process. She explained that the program is now accredited and must maintain a 70 percent passage rate. She said that during last quarter, the program had a 100 percent passage rate on the students' first attempt to pass the state examination.
