I. CALL TO ORDER:

President Ottesen called the meeting to order at 12:00 p.m. Deputy Superintendent Anderson led the Pledge of Allegiance. President Ottesen announced that Board member Clark was gravely ill and asked that we keep Greg in our thoughts and prayers.

II. ADDITIONS TO THE AGENDA: There were no additions to the agenda.

III. RECOGNITION:

Superintendent Mousalimas and the Board recognized students and coaches from the Foundations Academy who had been chosen to perform in San Francisco as part of the Hamilton Education Program. Three students performed their half-song, half-spoken word piece, which they had written themselves, and performed for over 2,000 people at the event.

Also recognized was the Venture Academy On Pointe Dance Team who had participated in the recent World Strides Competition in Anaheim. This was the eighth year they had attended and brought home the gold for the eighth time, as well as the Judges' Award for the highest score.

The Venture Academy Mock Trial Team was recognized for their win at the county-level competition and also for their sixth-place finish at the state competition. Coach Spencer Wright noted his appreciation for the support provided by the San Joaquin County Office of Education (SJCOE).

IV. COMMENTS:

Matthew Balzarini, Lammersville Unified school board member and regional director for CSBA, thanked SJCOE for their membership in CSBA and also the continued support of the school district. He noted that CSBA's platform includes a full and fair funding initiative, grass roots efforts for school board member participation in legislation, and governance training for its members. He offered his services as a resource and introduced Stephen Reid, CSBA's new PACER – Public Affairs Community Engagement Representative.

Mr. Reid added that he will serve as the liaison between CSBA, school districts, and county offices of education. His main focus is to assist with moving forward for full and fair funding and working toward a 2020 ballot initiative that will increase funding that will place California in the top half of the nation in per pupil public funding in 2022 and in the top five by 2025. He also offered his services as a resource.

He reported that Governor Newsom's May revise indicates there will be some much-needed relief for K-12 education to assist with the escalating pension rates.
