I. CALL TO ORDER:

President Ottesen called the meeting to order at 12:00 p.m. Division Director Ron Estes led the Pledge of Allegiance.

III. COMMENTS:

 Alfred Bloom, a resident of Stockton and parent of a student at Venture Academy, asked the Board to consider realigning, or aligning, the Venture Academy school calendar with the school calendar of the Stockton Unified School District. He also requested that the Board and other professional educators look at the current body of information related to a later start time for the high school classes, adding that research shows this change would benefit students.

IV. ITEMS SCHEDULED FOR INFORMATION:

1. Williams Uniform Complaints Quarterly Report: Superintendent Mousalimas presented the quarterly report that indicates there were no uniform complaints filed regarding the schools and programs operated by the San Joaquin County Office of Education between mid-July and mid-October.

2. Williams Settlement Annual Report: Superintendent Mousalimas presented the findings from the mandated Williams Settlement visits and review of Decile 1 – 3 schools in San Joaquin County reporting that each school district governing board also receives this information and reviews it at their individual governing board meeting. Assistant Superintendent Jane Steinkamp introduced Lisa Neugebauer, coordinator of the Williams Act Settlement, who shared the data provided by the group of retired school administrators who make up the team that visits the school sites. She reported that the team visited 8 school districts, 89 school sites, and 1,119 classrooms, as well as locker rooms, bathrooms, gyms, playgrounds, and parking lots. The Board asked questions regarding the process for remedy of the situations discovered during the school site visits. Ms. Steinkamp explained that, with the exception of emergency situations, the school districts are relied upon to address the items and there is no requirement for the county office to continue to monitor beyond the initial visit.
