- Credential Application Annual Report: Human Resources Director Christina Torres-Peters reviewed the annual Credential Application Report that illustrates the number of credential applications processed by the San Joaquin County Office of Education during 2019 2020, including temporary teaching certificate applications. Ms. Torres-Peters reported that a total of 424 credential applications were processed, 24 of which were renewal applications. In terms of temporary county certificates, a total of 821 applications were processed, which included 106 for San Joaquin County Office of Education (SJCOE) employees.
- 2. Declaration of Need: Human Resources Director Christina Torres-Peters and Human Resources Coordinator Aggie Christensen presented the Declaration of Need for Fully Qualified Educators report and said that based on the actual needs and projected enrollment for the upcoming year, the area of anticipated need for emergency permits includes CLAD and English Learner Authorization in the San Joaquin County Alternative Education and Special Education programs.

The estimated number of limited assignment permits includes 10 multiple subject credentials, 10 single subject credentials, and 20 credentials in the area of special education.

The establishment of an intern program and participation in a Commission-approved university internship program serves as evidence of efforts to certify, assign, and develop fully-qualified teaching staff. County Superintendent Mousalimas certified this report, which will remain in effect until June 30, 2021.
