## I. CALL TO ORDER:

President Dyk called the meeting to order at 12:00 p.m. Board member Vogel led the Pledge of Allegiance.

- II. ADDITIONS TO THE AGENDA: There were no additions to the agenda.
- III. COMMENTS: There were no comments from the audience, via email, or via telephone.

### IV. PUBLIC HEARING:

1. Charter School Petition Renewal: Division Director Kathy Focacci reported that the Venture Academy Family of Schools (Venture) petition renewal is before the Board for consideration of renewal. She explained that the charter school first opened in January 2002 with 11 teachers, one support staff, and 235 students and has grown to over 100 staff, 76 teachers, and approximately 1,600 students. She added that renewal petitions are required every five years making this the fourth renewal petition for Venture. Ms. Focacci shared a video highlighting the different academies and educational opportunities geared toward the diverse student population. Ms. Focacci introduced Director Janet Johnson, who provided information about the charter school including the mission and vision, programs provided, and the various sections in the petition renewal.

Associate Superintendent Troy Brown reported that he will lead a committee of San Joaquin County Office of Education staff in the review of the renewal petition using an evaluation matrix in alignment with new requirements per Assembly Bill 1505. The committee will provide a recommendation 15 days prior to the March meeting.

Board member Vogel asked questions regarding changes put in place due to the COVID-19 pandemic that addressed technology accessibility for students and student outcomes.

President Dyk opened the public hearing. There were no comments from the audience and the public hearing was closed.

## V. ITEMS SCHEDULED FOR INFORMATION:

- Williams Uniform Complaints Quarterly Report: Superintendent Mousalimas presented the quarterly report that indicates there were no uniform complaints filed regarding the schools and programs operated by the San Joaquin County Office of Education between mid-October and mid-January.
- 3. Sky Mountain Outdoor Education Center and Outdoor Education Update: Deputy Superintendent Scott Anderson reported that the acquisition of Sky Mountain Outdoor Education Center (Sky Mountain) was completed on December 22, 2020. He said that Sky Mountain is a 62-acre parcel on Lake Valley Reservoir located in the Sierra Nevada mountains that was donated as part of a 2003 settlement by the Pacific Gas and Electric Company. In addition to the land donation, Mr. Anderson noted that preexisting infrastructure, capital assets, and \$2.5 million to support compliance and infrastructure reinforcement were donated by the Pacific Forest and Watershed Lands Stewardship Council.

Mr. Anderson introduced Assistant Superintendent Jane Steinkamp, who reported students in San Joaquin County will no longer attend science camp at the Jones Gulch location owned by the YMCA but will attend at Sky Mountain instead. Ms. Steinkamp shared the benefits of students attending at Sky Mountain include SJCOE maintaining the facilities and controlling pricing for schools, a reduced commute time, and flexible scheduling opportunities which include students attending during the summer months.
